## **UNFINISHED BUSINESS:**

The board approved \$10,000 for this project. Quotes were requested from Munro Construction, Westbrooke Construction, and Apex Construction. The quote from Munro Construction was for \$5,911.00. The quote from Westrbrooke Construction was for \$7,860.00. A quote was not received from Apex Construction. Marva made a motion to approve the Munro Construction bid. Tom seconded the motion, all voted in favor, and the motion passed.
- B. <u>Strategic Plan Quarterly Update:</u> The board expressed their appreciation of this update and how it details each activity's date of completion.
- C. Officer Martin Tribute: The board discussed different ideas of ways to honor Officer Martin, who was killed in the line of duty. Jerry suggested the new community room in the former Chapter's Café be dedicated in the officer's honor. Jerry related that many conversations will take place in that room over time and the importance of conversations in fostering community cohesion. Tom made a motion that we dedicate the community room in the former Chapter's Café in honor of Officer Justin Martin. Jeff seconded the motion. All voted in favor and the motion passed.
