## **UNFINISHED BUSINESS:**

- C. <u>Art UP Close-Update</u>: Photographer Larry Mendenhall has been selected as the artist for Art UP Close. Julie showed a brief power point presentation of his photography work. Larry will conduct presentations and workshops throughout the community from April to the end of July.
- D. <u>Auditor's Report</u>: The board was seeking reassurance that steps have been taken to prevent further theft. Julie explained that the library adopted the city purchasing policy and offered to provide copies of the monthly bills for review. A.J. assured the board he was comfortable with preventative measures that have been adopted.
