**CALL TO ORDER:** Jeff called the meeting to order at 5:45 p.m. Greg W. read the Character Counts statement.

**APPROVE AGENDA:** Greg made a motion to approve the agenda. Marva seconded the motion. All voted in favor and the motion passed.

Officers may succeed themselves in office, provided none serves more than three *consecutive* terms in the same office. <u>Under Item III Meetings</u>: Article D Order of Business – Citizen's Forum agenda item should appear before Approve Bill list.

## **NEW BUSINESS:**

- A. Approve City of Urbandale Personnel Policy—Table of Contents: Approval of the City of Urbandale Employee Handbook is required for renewing our State Library of Iowa Accreditation. After reviewing the table of contents, Tom made a motion to approve. Greg seconded the motion. All voted in favor and the motion passed.
- B. <u>Approve 2010 ADA Standards for Accessible Design: Priority 1, Approach & Entrance</u>: Article 1.47 states: IF there are two doors in a series, e.g. vestibule, is the distance between the doors at least 48 inches plus the width of the doors when swinging into the space? Jeff measured and suggested that it should be checked yes instead of no. Kerry made a motion to approve after that change is made. Marva seconded the motion. All voted in favor and the motion passed.
